GROSS DOMESTIC PRODUCT OF GEORGIA IN 2020 (PRELIMINARY)

Based on preliminary estimates the nominal Gross Domestic Product (GDP) amounted to 49 407.3 million GEL in 2020, up by 0.3 percent YoY, while the real growth of GDP reduced by 6.2 percent. In 2020 GDP deflator percentage change equaled 6.9 percent YoY.





The largest shares of GDP by activity are held by Wholesale and retail trade; repair of motor vehicles and motorcycles (14.5 percent) and Real estate activities (11.7 percent), followed by Manufacturing (10.8 percent), Construction (8.9 percent), Agriculture, forestry and fishing (8.4 percent), Public administration and defence; compulsory social security (7.4 percent), Transportation and storage (5.9 percent), Financial and insurance activities (4.9 percent).



Real growth was registered in Human health and social work activities (7.9 percent), Agriculture, forestry and fishing (3.6 percent), Education (3.1 percent), Public administration and defence; compulsory social security (1.8 percent), Other service activities (7.1 percent).

A decrease in the real value-added was recorded in Accommodation and food service activities (-37.9 percent), Transportation and storage (-22.3 percent), Wholesale and retail trade; repair of motor vehicles and motorcycles (-5.6 percent), Arts, entertainment and recreation (-18.9 percent), Administrative and support service activities (-37.9 percent), Professional, scientific and technical activities (-18.4 percent), Construction (-4.7 percent) and Financial and insurance activities (-5.0 percent).
