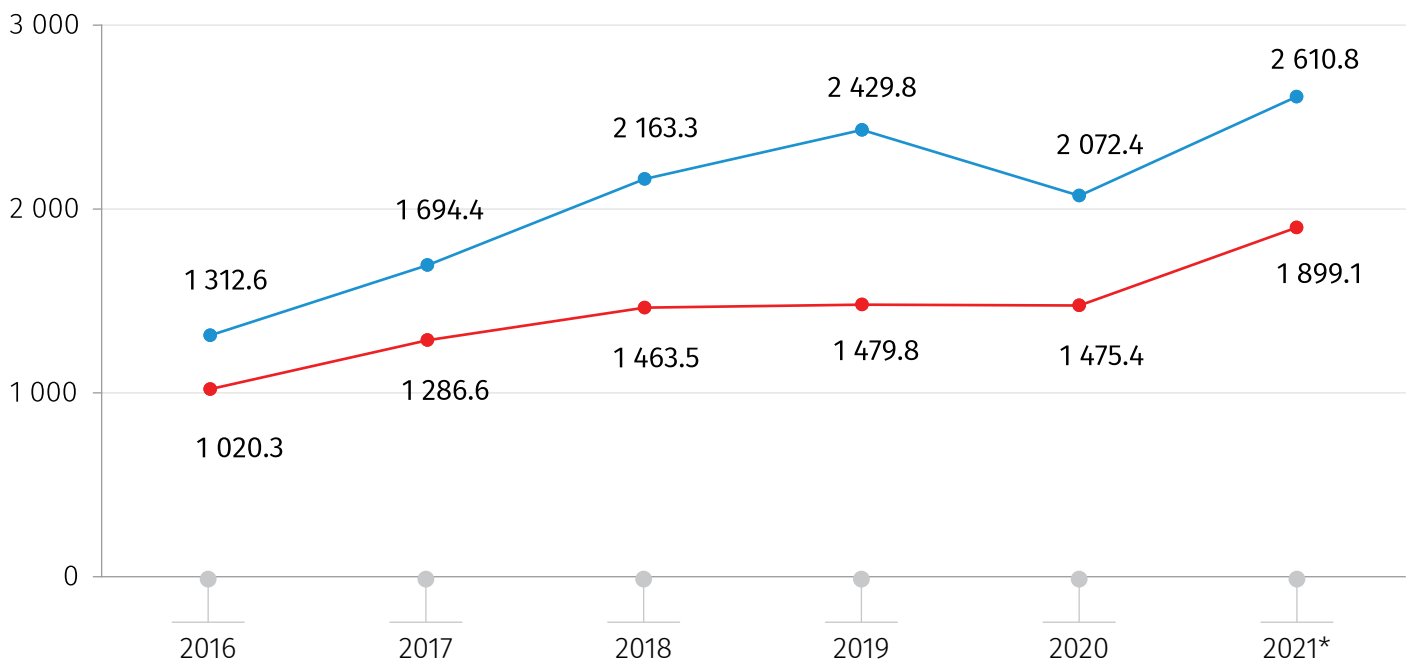

THE DOMESTIC EXPORTS IN JANUARY-AUGUST 2021

In January-August 2021 the exports of Georgia (excluding non-declared exports) equaled USD 2 610.8 million, 26.0 percent higher year-on-year. Share of the domestic exports in total export constituted 72.7 percent and amounted to USD 1 899.1 million, 28.7 percent higher to the same period of 2020.

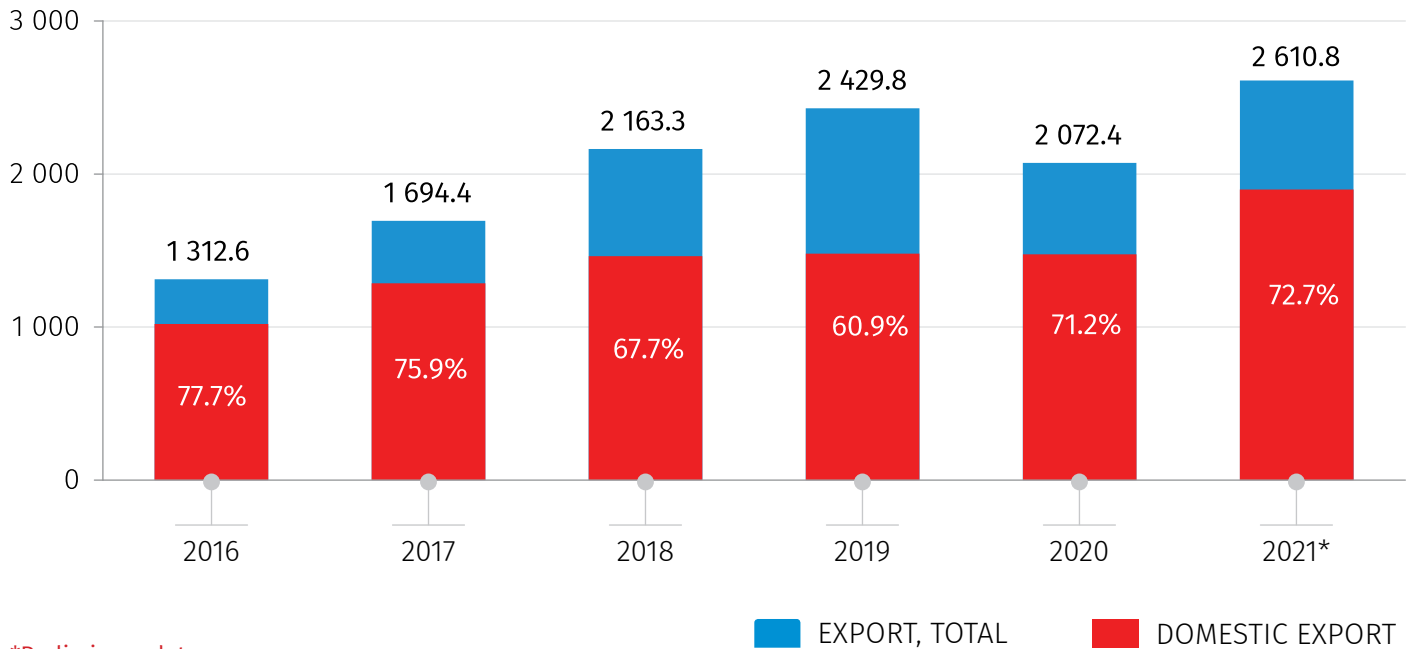

In January-August 2021 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 79.5 percent. The top partners were China (USD 400.1 million), Russia (USD 344.1 million) and Turkey (USD 200.8 million).

In January-August 2021 copper ores and concentrates reclaimed the first place in the list of top export items, equaling USD 517.9 million, or 27.3 percent of total exports. The exports of ferro-alloys totaled USD 265.5 million and their share in the total exports amounted to 14.0 percent. The exports of wine of fresh grapes occupied the third place standing at USD 143.7 million and constituting 7.6 percent of the total exports.
