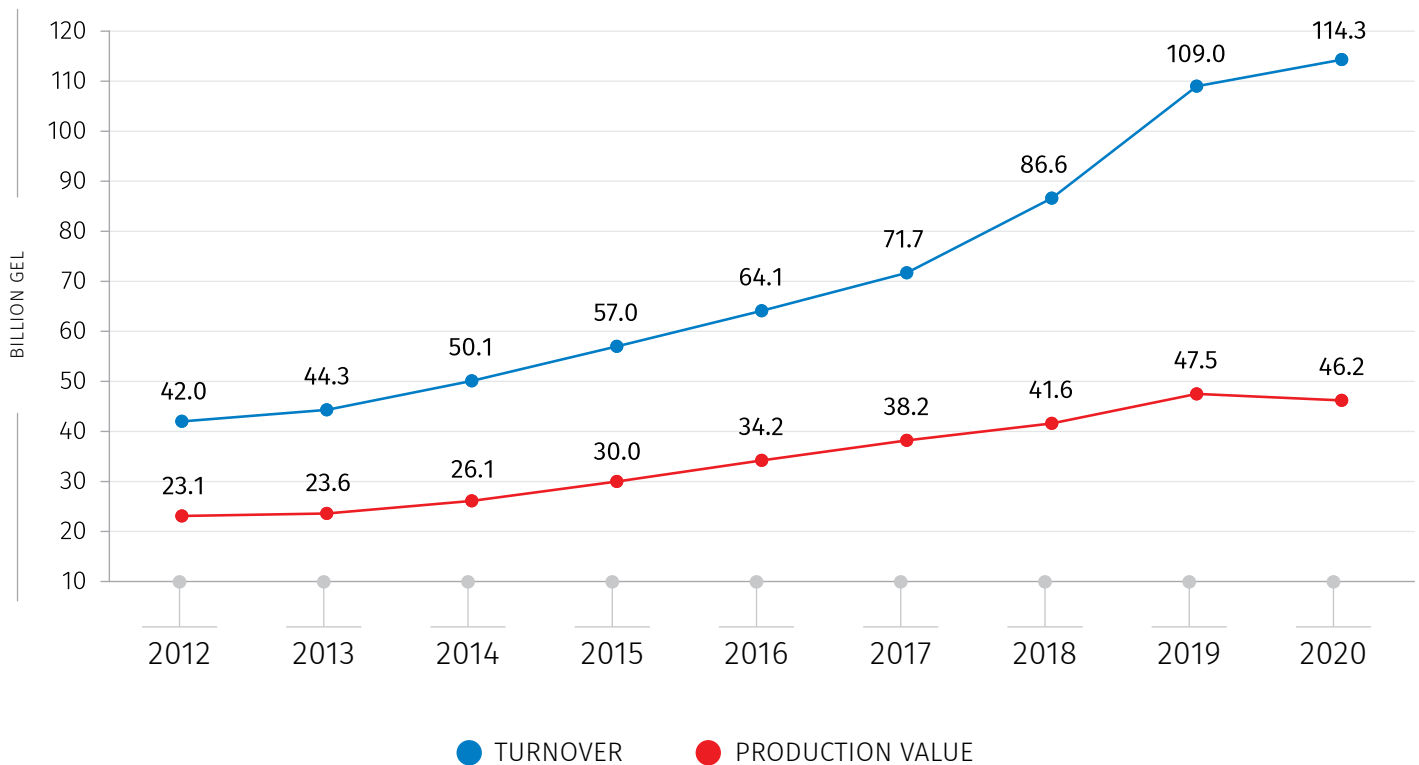

ACTIVITIES OF ENTERPRISES, 2020

In the Year 2020 compared to the previous year the volume of business sector turnover increased by 4.9 percent and amounted to 114.3 billion GEL.

The production value of the business sector is characterized by the less tendency. In the Year 2020, its volume equaled to 46.2 billion GEL, which is year-on-year 2.7 percent higher:

CHANGE IN THE VOLUME OF BUSINESS SECTOR TURNOVER AND PRODUCTION VALUE BY YEARS



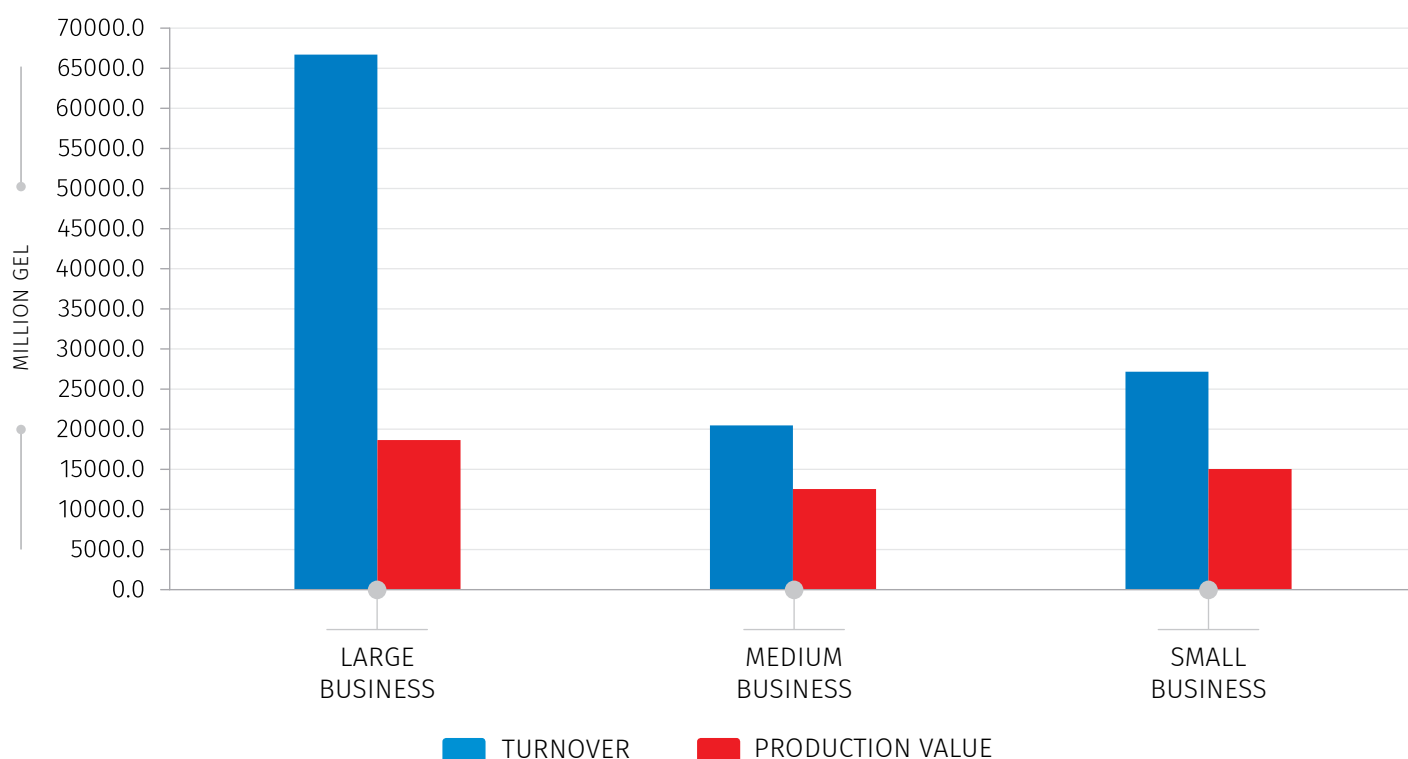

In the Year 2020, 58.3 percent of total turnover comes on large and 17.9 percent - on medium businesses while 23.8 percent is distributed to small business.

A small difference is in case of total production value: 40.3 percent comes on large, 27.1 percent – on medium and 32.5 percent on small businesses.

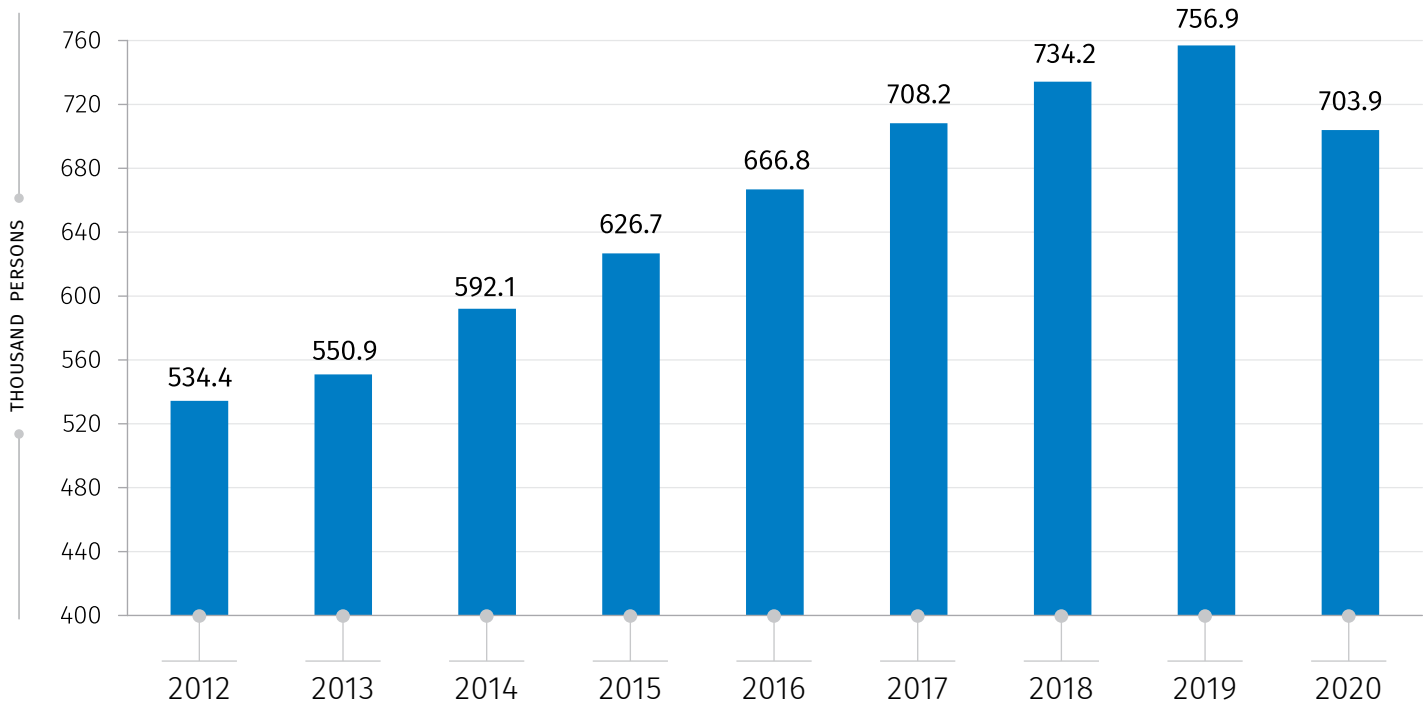
BUSINESS SECTOR TURNOVER AND PRODUCTION VALUE BY SIZE OF ENTERPRISES, 2020



In the Year 2020, total purchases of goods and services carried out by enterprises equaled to 65.1 billion GEL, while the purchase goods and services for resale amounted 41.1 billion GEL. Both indicators are insignificant less than last year

In the Year 2020, the average number of employees equaled to 703.9 thousand, which is year-on-year 7 percent less. Out of the total number of employees, 41.5 percent are female and 58.5 percent are male.

37.2 percent of total number of employees comes on large, 21.7 percent – on medium and 41.2 percent - on small businesses.

The total number of employed persons amounted 656.3.0 thousands (year-on-year 6.5 percent less). The total personnel costs of enterprises equaled to 9 828.1 million GEL

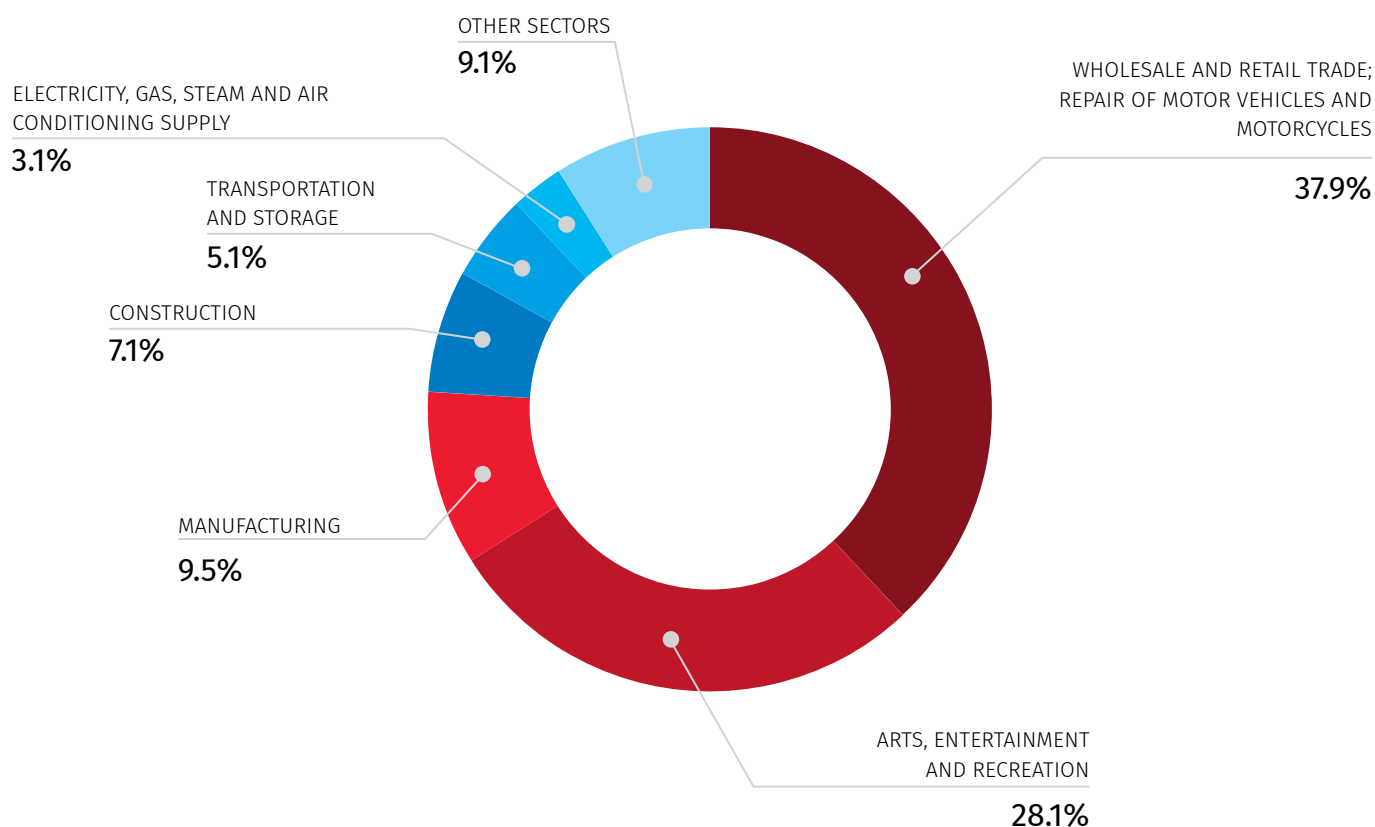
In the Year 2020, average monthly remuneration of employed persons equaled to 1 222.9 GEL (year-on-year increase by 61.2 GEL) while remuneration of employed women made up 952.0 GEL (year-on-year increase by 87.4 GEL). Average monthly remuneration of employed persons by size of enterprises is as follows:

- LARGE BUSINESS – 1 322.9 GEL
- MEDIUM BUSINESS – 1 419.6 GEL
- SMALL BUSINESS – 991.6 GEL

In the Year 2020 the trade sector (including repair of motor vehicles and motorcycles) has the highest share (37.9 percent) in the total turnover in business sector, followed by arts, entertainment and recreation with 28.1 percent share, manufacturing – 9.5 percent, construction – 7.1 percent, transportation and storage – 5.1 percent, electricity, gas, steam and air conditioning supply – 3.1 percent and other sectors with 9.1 percent share:

TURNOVER IN BUSINESS SECTOR, 2020

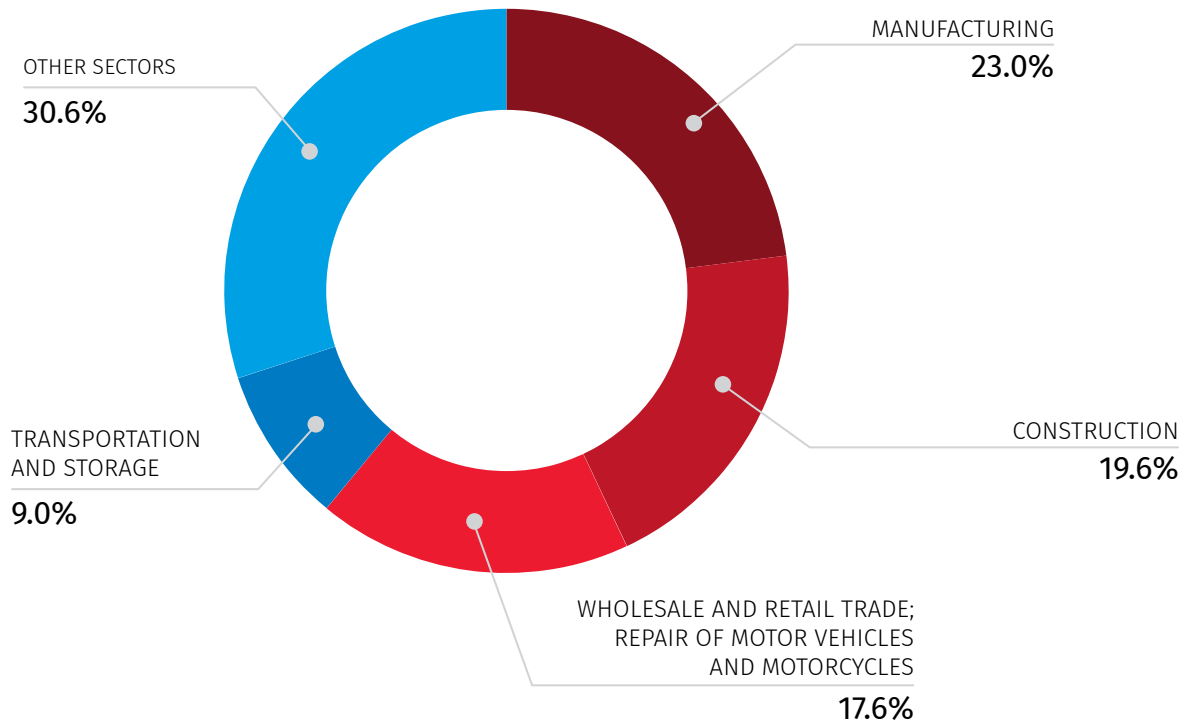

In the Year 2020, manufacturing (23.0 percent), construction (19.6 percent), trade (17.6 percent) and transportation and storage (9.0 percent) are on the top four places in business sector production value. Rest of sectors have the 30.6 percent share:

PRODUCTION VALUE IN BUSINESS SECTOR, 2020

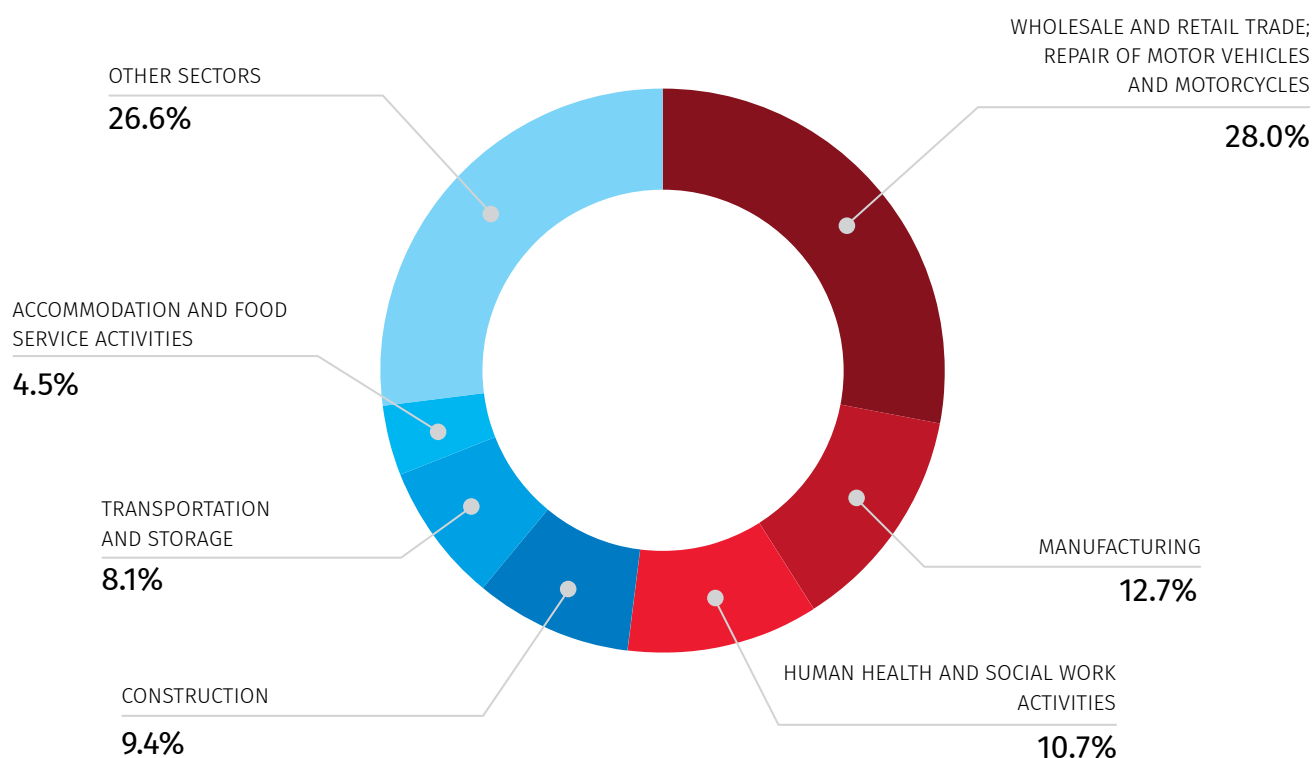

In the Year 2020, trade (wholesale and retail trade, repair of motor vehicles and motorcycles), manufacturing and human health and social work activities are leading in business sector by number of employees (accordingly with 28.0 percent, 12.7 percent and 10.7 percent share). However, enterprises engaged in construction (9.4 percent), transportation and storage (8.1 percent) and accommodation and food service activities (4.5 percent) have also a significant share:

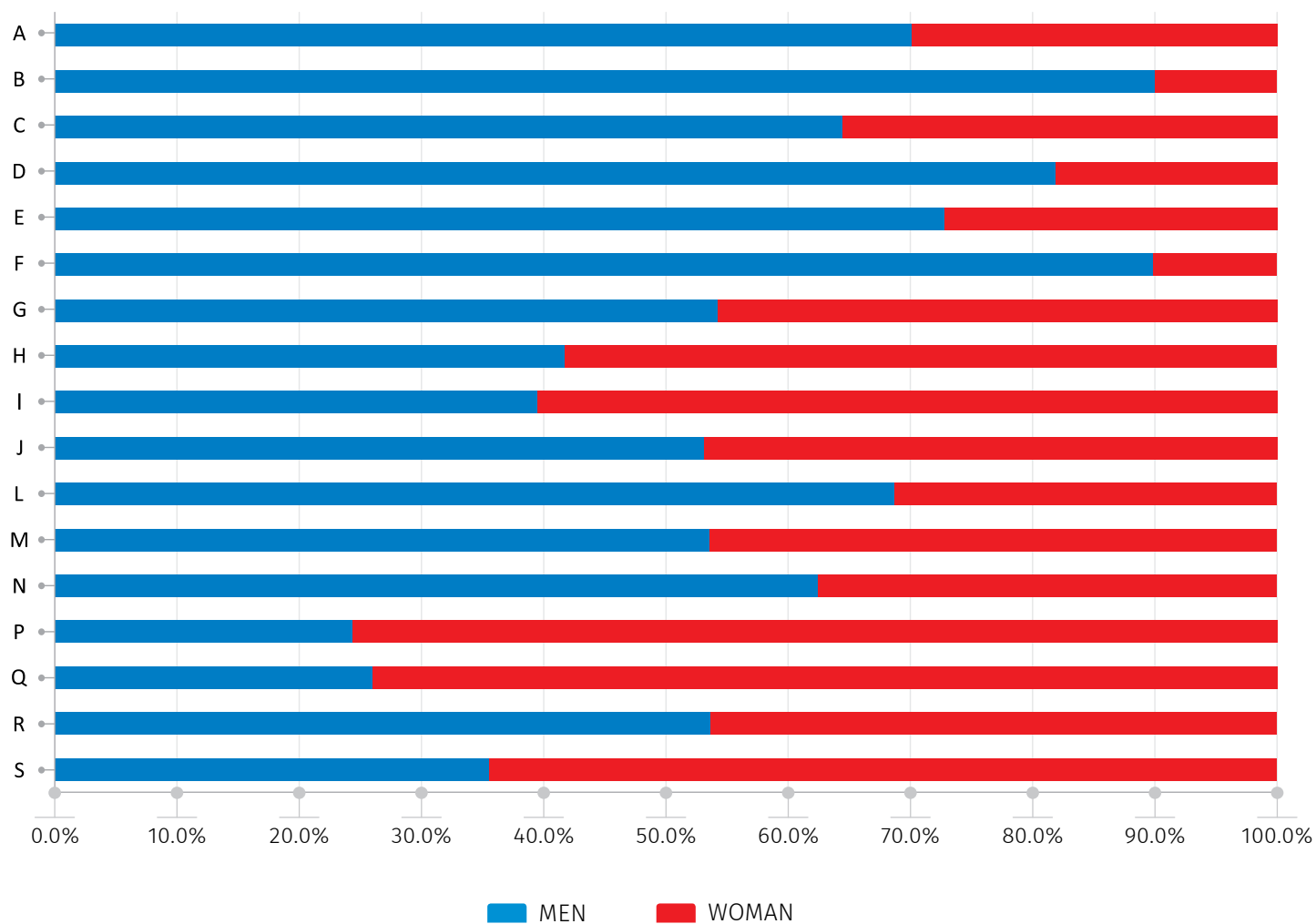
**NUMBER OF EMPLOYEES IN BUSINESS SECTOR,

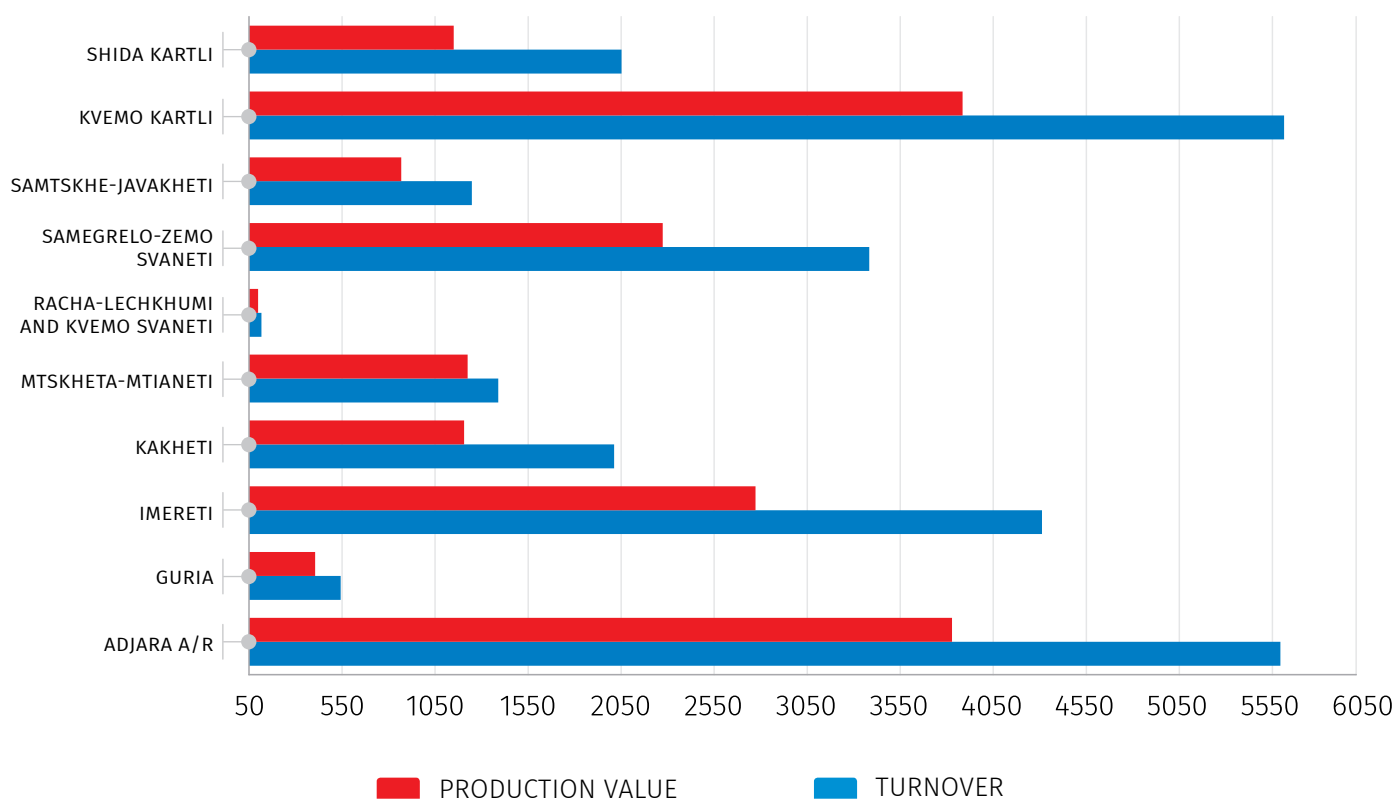
By regions, Tbilisi and following regions are leading in **gross turnover**:

- Tbilisi – 61.6 percent
- Adjara – 8.3 percent
- Kvemo Kartli – 8.4 percent
- Imereti – 6.0 percent
- Samegrelo-Zemo svaneti – 4.9 percent

The chart below shows turnover and production value by region, except Tbilisi (in mln GEL):



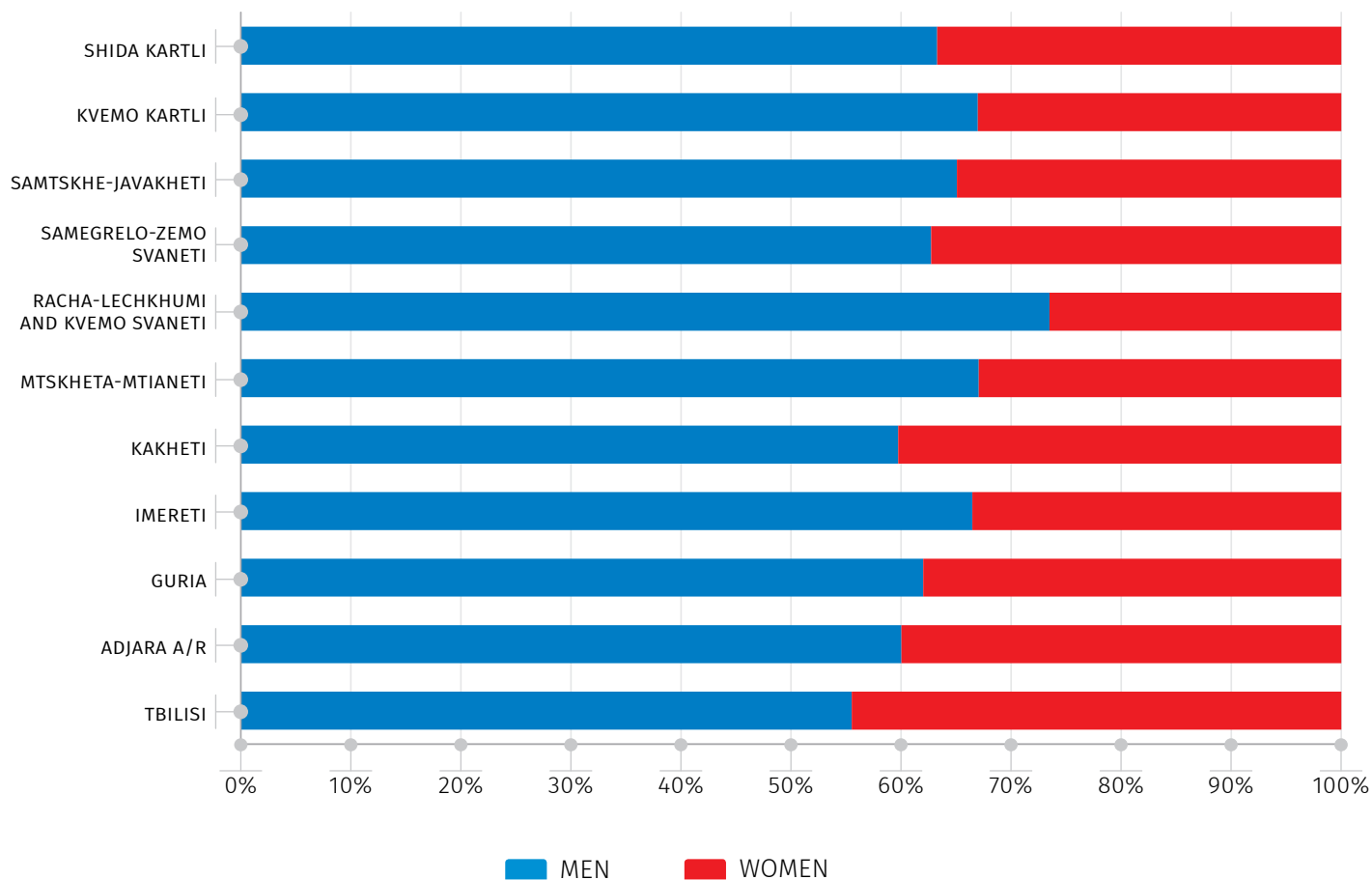
