Instruction

During the interview, the household member / members who are informed about the amount of expenses incurred in the field of real estate operations will be interviewed.

The questionnaire includes a single table in which expenditures are grouped in the real estate sector by 2019 by service groups and funding source. The questionnaire includes the following groups of real estate services:

1. **Services for renting and operating of own or leased real estate (Residential Buildings)**- includes services for renting and managing housing by their owners or tenants: houses, apartments, apartment buildings, mobile parking lots, etc.
2. **Services for renting and operating of own or leased real estate (Non-residential Buildings)**- includes services renting and managing industrial, commercial or other non-residential buildings or property by their owners or tenants: warehouses of industrial and administrative buildings, theaters, congress palaces, exhibition halls (Non-residential type) and buildings with many purposes etc.
3. **Services of Real Estate Agencies activities on a fee or contract basis** - includes real estate services related to the sale of houses, flats, apartment buildings and other residential buildings, and similar intermediary services related to the sale and purchase of residential buildings and land occupied by them, on a rental basis or on a contract basis.
4. **Real estate management services on a fee or contract basis** - includes services on the operation of residential, industrial and commercial buildings, multifunctional buildings, on a fee or contract basis, services on agricultural, forestry and similar property management.

The second part of the questionnaire includes the expenditures made in the field of real estate operations in 2019 according to the sources of financing:

1. **Private person** - is a private person, both the recipient of the real estate activities, as well as his / her family member or other sponsor, which does not belong to the other source of funding given in the questionnaire.
2. **Private company** - a company registered as a legal entity.
3. **International / non-governmental organization**
4. **State** - includes funding for both central and local municipalities.
5. **Other sponsor (please indicate)** - Other sources of funding that do not fall into the above categories.
6. **Expenses incurred by another sponsor** - Expenses incurred by another sponsor.

If it is impossible to conduct an interview with the given Household, it is necessary to survey other households in the same area to ensure a selectively determined number of households surveyed.
