GROSS DOMESTIC PRODUCT OF GEORGIA IN 2021 (PRELIMINARY)

Based on preliminary estimates the nominal Gross Domestic Product (GDP) amounted 60 231.6 million GEL in 2021, up by 22.3 percent YoY, while the real growth of GDP increased by 10.4 percent. In 2021 GDP deflator percentage change equaled 10.8 percent YoY.

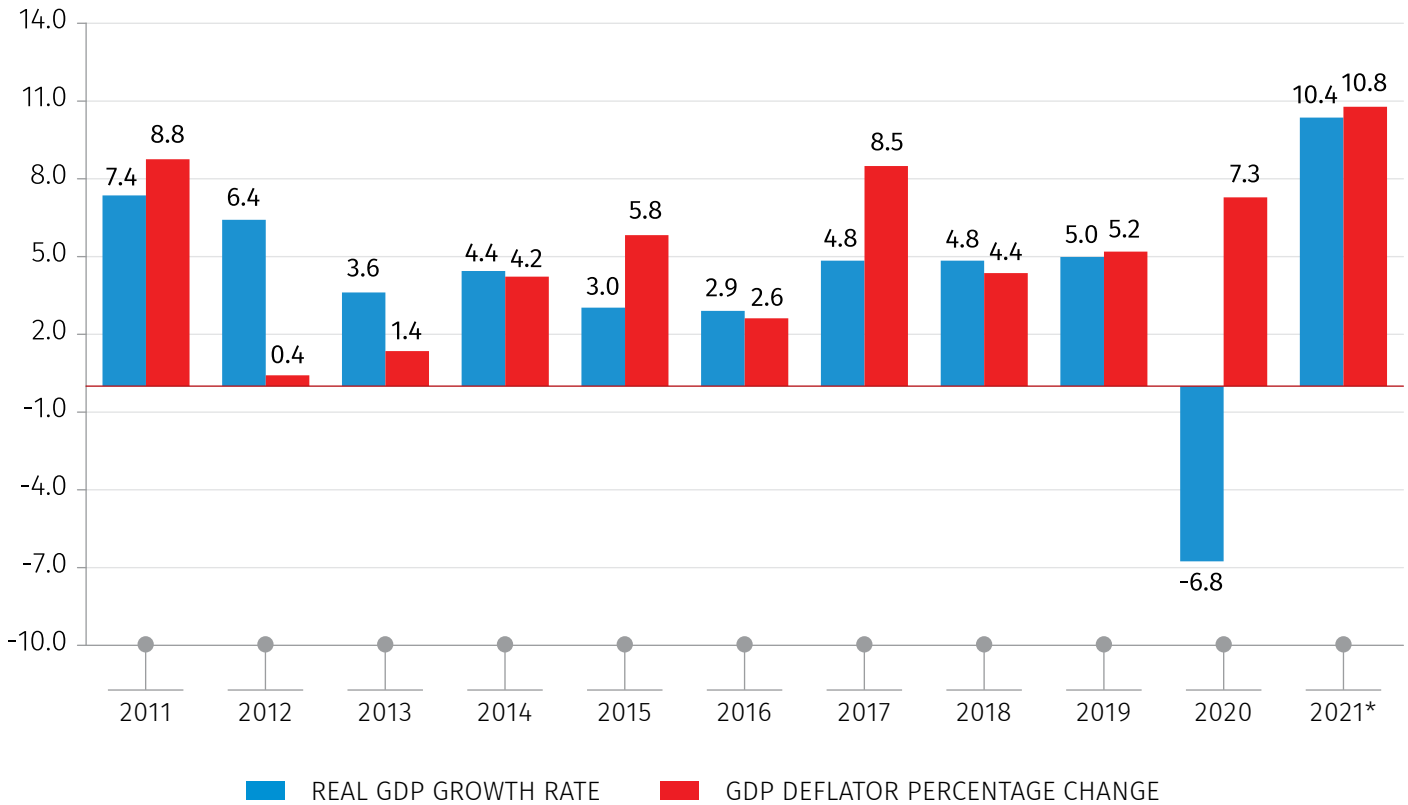

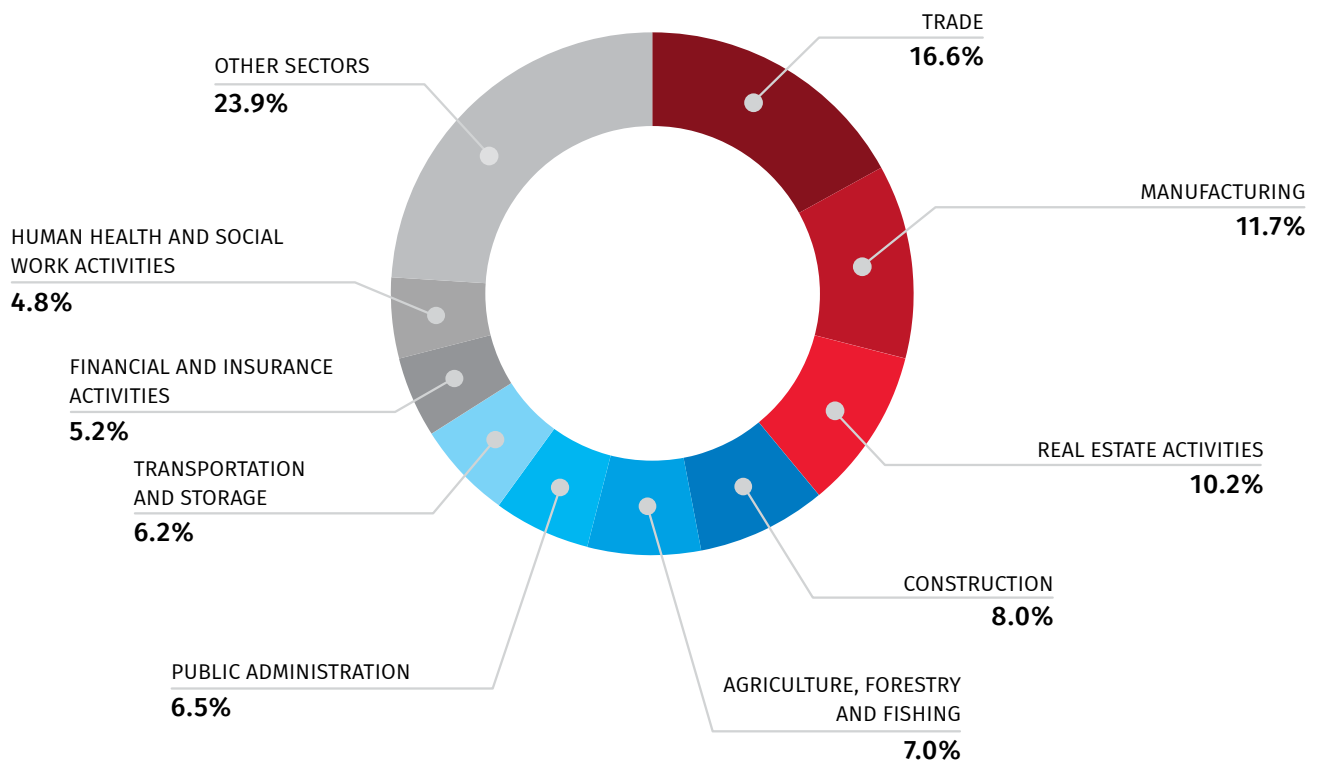

The largest shares of GDP by activity are held by Wholesale and retail trade; repair of motor vehicles and motorcycles (16.6 percent) and Manufacturing (11.7 percent), followed by Real estate activities (10.2 percent), Construction (8.0 percent), Agriculture, forestry and fishing (7.0 percent), Public administration and defence; compulsory social security (6.5 percent), Transportation and storage (6.2 percent), Financial and insurance activities (5.2 percent), Human health and social work activities (4.8 percent).

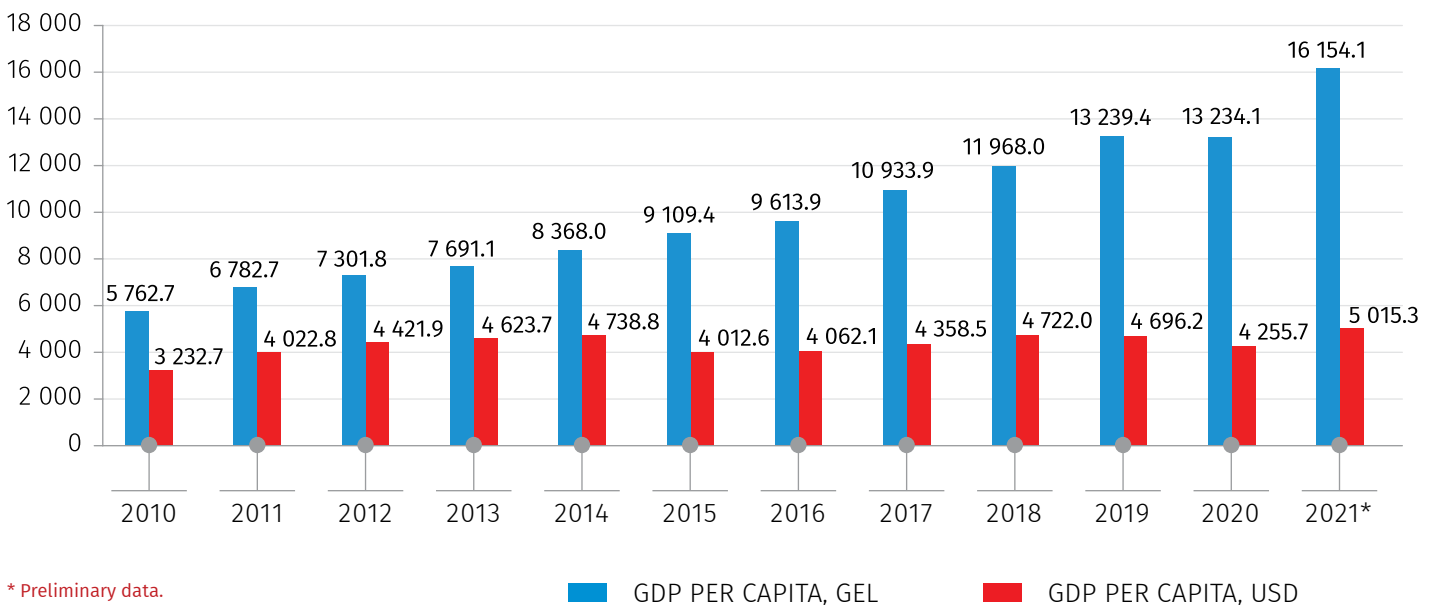

Real growth was registered in Wholesale and retail trade; repair of motor vehicles and motorcycles (19.9 percent), Transportation and storage (27.6 percent), Arts, entertainment and recreation (43.1 percent), Human health and social work activities (28.7 percent), Financial and insurance activities (23.5 percent), Real estate activities (9.2 percent), Manufacturing (9.0 percent), Accommodation and food service activities (29.8 percent), Electricity, gas, steam and air conditioning supply (33.5 percent), Information and communication (23.9 percent), Mining and quarrying (13.5 percent).

A decrease in the real value-added was recorded in Construction (-21.8 percent), Agriculture, forestry and fishing (-1.4 percent), Education (-2.3 percent), Public administration and defence; compulsory social security (-0.9 percent).
