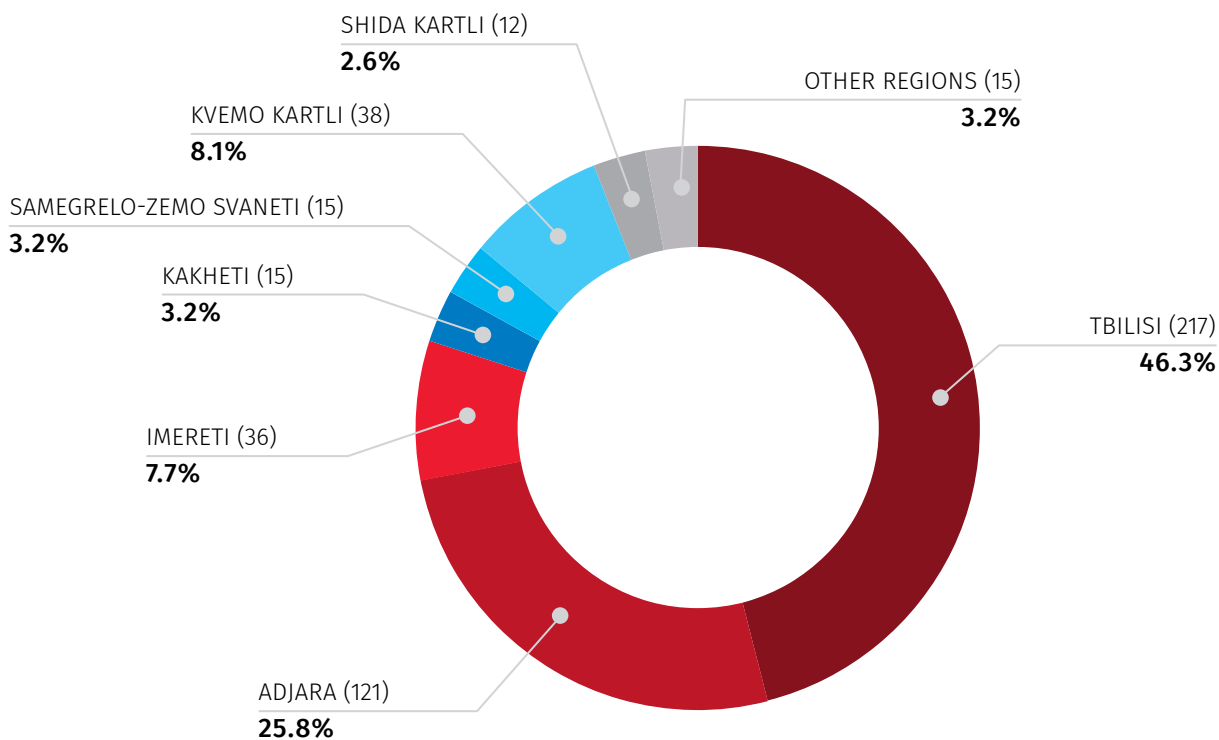

**GENERAL RESULTS OF CURRENCY EXCHANGE UNITS' SURVEY
(2021)**

In 2021 the number of active currency exchange units (except commercial banks, microfinance institutions and local units) was 469 in Georgia, 46.3 percent of which were located in Tbilisi, 25.8 percent - in Adjara region, 8.1 percent - in Kvemo Kartli region, 7.7 percent - in Imereti region, 3,2 percent – in Kakheti region, 3,2 percent –in Samegrelo-Zemo Svaneti region and rest 3,2 percent – in other regions:

In 2021 year the total turnover of currency exchange units has been 6.4 billion Gel, 51.8 percent of which was USD, 14.7 percent EURO, and 33.5 other currency¹.

543.0 mil. USD and 135.3 mil. EURO has been purchased by currency exchange units in 2021. In the same time amount of sold USD and EURO was 520.5 and 132.0 million properly.

In 2021 number of clients ensured with services by currency exchange units were 1 664 thousand. From where number of individuals equaled to 1 651 thousand. While 13 thousand was legal entity. 85.9 percent of clients ensured with service were locales and rest of 14.1 percent foreigners.

The amount of cash in cashbox (converted in Gel) has been 29.7 mil Gel 37.0 percent of which was USD, 10.7 percent – EUR and 52.3 percent other currency. Total amount of cash in banks (1.8 mil Gel) was only distributed on resident banks.
