Please, read the following information to the respondent: The purpose of the Non-Observed Economy Statistical Survey in Transportation Sector is to determine expenditures (both monetary and non-monetary) on transportation and storage services in 2020. The study does not include expenses incurred for entrepreneurial activities.

The survey consists of two parts:

Part 1 - Expenditures on transportation services

1.1 - Expenditures on land transport services include household expenditure on passenger and freight land transport services. Land transport includes vehicles such as: minibus, bus, car, rail transport, Funicular/teleferics and other land vehicles;

1.2 - Expenditure on water transport services includes household expenditure on passenger and freight water transport services. Water transport includes means of transportation such as: ship, boat, yacht, ferry, cargo tankers and etc.;

1.3 - Expenditures on air transport services include household expenditure on passenger and freight air transport services. Air transport includes means of transportation such as: aircraft, helicopter, airship, balloon and any other type of aircraft;

1.4 - Expenditures on warehousing and support services for transportation include household expenditure on warehouse/storage and support activities incidental to land/water/air transportation. Warehousing services include services for refrigerated warehouses, storage of liquid and gaseous cargo and operation of grain silos. Transport-related support services include services to travel stations/airports, dispatch points and etc.;

Part 2 - Expenditure on purchasing and exploitation of the vehicle

2.1 - Expenditures on purchases of vehicle - include household expenditure on purchases of vehicle, which have never been in exploitation inside the country;

2.2 - Expenditures on exploitation of vehicle - include household expenditure on exploitation and maintenance of vehicle inside the country;
